Since its founding in 1919, the American Legion remains steadfast in its support of a strong national defense, which is reflected in the Preamble to The American Legion Constitution: "To uphold and defend the Constitution of the United States of America," and "to safeguard the principles of justice, freedom, and democracy."

The American Legion's national-security position is multifaceted. Key aspects include:

- A well-funded, well-equipped and well-trained military.
- Awareness and surveillance of rogue nations, terrorist

groups and global threats to U.S. security around the world. Support for the Department of Homeland Security and urging its steadfast protection of U.S. borders, ports and other points of access.

• Comprehensive disaster preparedness.

 A decent guality of life for troops and their families – active-duty and reserve components alike – that includes reasonable compensation, benefits, health care, child care and family-support programs; and an efficient and compassionate healing and transition program for wounded and ill warriors.

I am not sure how many of you subscribe to "The America Legion E-Mail Newsletter". It is a monthly e-mail letter with alerts that come out periodically from the National Commander on important issues. For instance, I received an alert yesterday that addresses the issue in support of a Constitutional Amendment regarding the desecration of the American Flag. This is what he says:



"As you may know, The American Legion has regularly encouraged Congress to pass a constitutional amendment that would give it the power to protect the Stars and Stripes from desecration. But we are not alone in this belief. The U.S. House has routinely passed such an amendment. Every state has endorsed such a resolution. And surveys show that 80 percent of



Americans agree that the flag should be protected. Now, President-elect Donald Trump has called for penalties against those who treat the American flag with disrespect. In a tweet, Trump wrote, "Nobody should be allowed to burn the American flag - if they do, there must be consequences - perhaps loss of citizenship or year in jail!"

While The American Legion does not have a position on what the penalty should be for those who violate our sacred flag, it does stand resolute in petitioning Congress for the necessary constitutional amendment. Our belief is not to silence those who

protest perceived injustices. Americans have the right to voice their views in respectful ways".

He wrote more, but you will have to go the National Website to read what he says. During this past election, the candidates continually addressed the "uninformed voters". As patriots, we can't afford to be uninformed. I challenge each of you to register on "The American Legion" website so that you can receive emails from our National Headquarters. This will inform you about the issues of today. I always enjoy reading the "Burn Pit" articles where legionnaires have a chance to address issues that affect the Legion. Doss who saved 75 men in Okinawa, during the bloodiest battle of WWII, without firing a single shot.

Believing that the war was just but killing was nevertheless wrong, he was the only American soldier in WWII to fight on the front lines without a weapon. As an Army medic, Doss single-handedly evacuated the wounded near enemy

lines - braving enemy fire and putting his own life on the line. He was the first conscientious objector ever to be awarded the Medal of Honor. While watching this true story, I reflected upon the fact that freedom is not free. and blood has been shed to free us as a nation. I am so grateful for those who have served in our military and who are willing to protect all of us from those who want to do harm to us. Thank you so, so much.

POW/MIA News

Bergdahl Pardon Request

The New York Times reported Dec 3, 2016 that Sgt Bowe Bergdahl is asking President Barack Obama to pardon him before leaving office. White House and Justice Department officials on that date said Bergdahl had submitted copies of the clemency request seeking leniency. If granted by Obama, it would allow Bergdahl to avert a court-martial trial scheduled for April where he faces charges of desertion and

misbehavior before the enemy, the latter of which carries a maximum penalty of life in prison. Bergdahl of Hailey, Idaho walked off his post in Afghanistan in 2009 and was held captive by the Taliban and its allies for five years. He was released in May 2014 in exchange for five Taliban prisoners held at Guantanamo Bay, Cuba.

Following the Vietnam War leniency was granted to American POWs who cooperated with their captures despite considerable efforts by senior-ranking POWs to bring charges against them. This precedent may have some influence on President Obama's decision.

The American Legion Auxiliary has sponsored the VA Gift Shop for over 60 years at the George Wahlen VA Medical Center. The Gift Shop serves any veteran registered in the VA system who is in need of assistance for Christmas. During the three days the Gift Shop is open, veterans bring information about their families (sizes, ages, etc.) and are allowed to choose gifts for themselves and their immediate family (sons, daughters, parents, grandchildren). Volunteers assist the veterans in "shopping", wrap the gifts and they can either take them with them or the Auxiliary will mail them. There is no charge for the gifts, wrapping or mailing.

All of the items the Gift Shop has available are donated by Units, individuals or companies or purchased by the Utah American Legion Auxiliary through donations. Longtime Auxiliary members believe it was originally set up for inpatients. The Auxiliary used to take a cart of gifts up to the wards, but this practice has expanded to serve any veteran that is registered with the VA. This includes also the veterans residing at the Veterans Homes. Dates for 2016 VA Gift Shop are December 5 – 7, Bldg. 8, Multi-purpose Room. Hours are from 9:00 am – 3:00 pm, except Wednesday, which is 9:00 am to 1:00 pm.
