
The American Legion is the place for you to help your buddy and for your buddy to help you. Founded in 1919, it is the largest veteran's organization in the United States with more than 2 million members.

us. There is one nice solution to avoid this hassle. PAID UP FOR LIFE! The American Legion rolled out a simplified application process and cost calculation formula for the national PUFL plan. Anyone who is currently an American Legion member or who is eligible for membership may become a PUFL member. Legionnaires can apply for a PUFL membership online at www.legion.org/join/pufl. After providing a name and member ID number, the member will receive a cost quote: he or she can pay by credit card or print out a personalized form and mail it in with a check or pay in 12 equal monthly payments. If the member pays in full online, he or she will receive a \$100 automatic discount applied at the time of

application. You can also contact Customer Service at 1-800-433-3318 for their personalized offer. When paid in full, the member will receive a permanent plastic card identifying him or her as a lifetime member. Also, no refund will be made if the member chooses to cancel membership or discontinue participating in the monthly payment plan. For general questions about the PUFL program, contact Internal Affairs at (317)630-1330. Once the member pays in full, he or she will be protected from any future dues increases at the post, department or national levels. As you can see above, we only have 9 PUFL members in our post.

Our \$35 annual membership dues are due now for the 2017 membership year. We are getting closer to our 100% goal. We would like the rest of the members to renew now, or in the near future. However it is never too late to renew. To keep your continuous membership intact, you will need to renew soon. **LEGACY SCHOLARSHIP APPLICATION ONLINE**: The American Legion Legacy Scholarship application for 2017 is online for new and returning applicants to fill out. The Legacy Scholarship is available for children whose parents lost their lives while honorably serving on active duty on/or after 9/11, AS WELL AS for children of post 9/11 veterans with a VA disability rating of 50 percent or higher. The renewable scholarship will award up to \$20,000 for the expense of graduate or post graduate tuition, books, room and board, meal plans, transportation and other supplies needed to achieve a higher education. ## **POW/MIA News**

Vietnam.



The POWs held in North Vietnam started coming home 44 years ago this month during Operation Homecoming. A total of 602 POWs were released between 2-12-73 and 4-1-73. This was the result of the December 72 Operation Linebacker II B-52 attacks against North Vietnam, mining of ports and the subsequent Peace Accords signed at Paris in January 1973.

One report lists 325 Air Force, 138 Navy, 77 Army, 26 Marines, 25 Civilians and 11 Foreign Nationals released. There were several releases of around 100 at intervals of about two weeks. Typically two C-141 transports and one C-130 support aircraft brought released POWs from the airport at Hanoi to Clark AB in the Philippines. Louds shouts of joy sounded in each C-141 at take-off and when crossing the coast of

After the C-141s parked at Clark AB, the anxious passengers were asked to form a line in order of their shoot down date. Each former POW was introduced as they departed the plane. Large crowds and TV cameras greeted them. Cmdr Jeremiah Denton (shot down 06/18/1965) bumped LTJG Everett Alvarez, Jr. (shot down 08/05/1964) out of first place on the first flight. He was given a microphone to address the waiting crowd. "We are honored to have had the opportunity to serve our country under difficult circumstances. We are profoundly grateful to our <u>Commander-in-Chief</u> and to our nation for this day. God bless

America." Alvarez who later served as Deputy Director of the Peace Corps and Deputy Administrator of the VA would have been equally eloquent.



American Legion members too feel honored to have served and grateful to be able to still do so. Jeremiah Denton Rear Admiral (Ret), U.S. Senator representing Alabama from 1981 – 1987 died in 2014 at the age of 89 and is buried at Arlington National Cemetery. After a year in captivity he was forced to have an interview with a Japanese reporter. The "V" were embarrassed by his actions. He was creative enough to blink in Morse code "T-O-R-T-U-R-E." Asked about his treatment, Denton responded—contrary to his thin and haggard appearance: "I get adequate food and adequate clothing and medical care when I require it."

**Asked about his views on the actions of the U.S. government, he said:** "I don't know what is happening, but whatever the position of my government is, I support it—fully. Whatever the position of my government is, I believe in it—yes sir. I'm a member of that government and it is my job to support it, and I will as long as I live." **His response took more than a little back bone.**
