Project Operation Verify. The American Legion National Headquarters issued a memorandum on December 10, 2013 which provided new guidance on the IRS and the issue of service verification/ DD-214s. DD Form 214 is no longer absolutely required by the IRS. Various methods of providing eligibility are outlined in the memo. In short, DD Forms 214 are now required only if there is doubt of eligibility by an agent (IRS). Post 27 members may still continue to provide copies to the Post Adjutant as back-up to their own personnel files.

The problem is now counted in the hundred thousands, and with veterans of the Iraq and Afghanistan wars returning home and re-entering civilian life, the backlog continues to grow in both volume and complexity.

It is reported that the American Legion has more than 2000 service officers working every day to help veterans correctly file for their benefits. The VA has piloted and implemented many promising programs to accelerate the claim process, but they still have a long way to go. If you, or know of a veteran, having a problem with filing a VA claim please contact us and we will provide you with a service officer who can help. There also web sites and a phone application available for filing VA claims through www.va.gov.

Comrades: I am sure you recognize that the 13 members of the Honor Guard are quite proud of the service we are honored to give families of the veterans who have departed for "Post Everlasting". I have been entrusted to coordinate our activities for military funeral honors and report the volunteer hours of 13 trained and dedicated members of the team.

We completed 55 Military Honors at Funerals in 2013. The average time spent from the pick-up of equipment at the Post, travel to the cemetery and return to the post and store, clean equipment and return home is $3\frac{1}{2}$ hours. Assuming a contingent of 5 individuals times 3.5 hours equals 17.5 hours for each funeral, equates to 962.5 hours of volunteer time. 962.5 hours divided by the 13 members of the team gives a total of just over 74 hours for each of the team members have averaged for the year.

I recognize that not all are able to join this honored group because of health, age, or work, however if you can find the time, please consider.

POW/MIA News

ARLINGTON, Va. (AFNS) -- Exactly 45 years after an Air Force pilot disappeared over Laos, his family finally had their chance to say their goodbyes in a repatriation ceremony at the Air Force Memorial here Dec. 13. Following the ceremony, Col. Francis J. McGouldrick Jr.'s family accompanied his flag-draped coffin to Arlington National Cemetery for burial.

On Dec. 13, 1968, McGouldrick served as a navigator on a B-57E Canberra on a night strike mission when the aircraft collided with a C-123 Provider over Savannakhet Province. McGouldrick was never

seen again and was listed as missing in action. In July 1978, a military review board amended Jay Hess McGouldrick's official status to *presumed killed in action*, according to a DoD POW/Missing Personnel Office news release. Between 1993 and 2004, several attempts to locate the crash site proved unsuccessful, but on April 8, 2007, a joint team located a possible crash site near the village of Keng Keuk.

From October 2011 to May 2012, joint U.S. and Laos teams recovered human remains and aircraft wreckage consistent with a B-57E. Joint POW/MIA Accounting Command scientists and the Armed Forces DNA Identification Laboratory used circumstantial evidence and forensic identification tools, such as mitochondrial DNA, which matched McGouldrick's great nephew and niece, to identify McGouldrick, according to the release. Before the family received the answers they'd been searching for since they first learned McGouldrick was declared missing, his wife Jacqueline and two siblings died. However, his children and grandchildren were able to finally see him return and receive the burial with full military honors he was due.

McGouldrick's ceremony was the first of its kind at the Air Force Memorial. However, Barbara Taylor, the Air Force Memorial's managing director, expects there to be more, with another veteran's family

already expressing interest in having their service on the site overlooking Washington. There remain more than 1,600 American service members still unaccounted for from the Vietnam War, according to DoD figures.

In the Rear with the Gear

Ask any combat soldier and he'll tell you that "headquarters" is one of the great misnomers of wartime. The truth is that all headquarters are really hindquarters, planted safely in the rear of a war zone to dispatch and control the personnel actually risking their lives in the line of fire at the real head of combat. So it is not surprising that, among themselves, troops often speak of "reporting to hindquarters" or identifying a new officer as having come to the front "straight from hindquarters."

It also refers to the disparity between the seat of intelligence, the human brain, and the just plain seat, the human hindquarters. This formulation may have been initially articulated by whoever was the first to mock, sometime in 1862, an expression that the insufferably pretentious and enormously unpopular Union Major General John Pope

liked to use. He made it his custom to begin all of his written orders with the dateline phrase, "Headquarters in the Saddle." Pretty soon, someone – no one knows who – pointed out that this described to a tee General Pope's chief weakness as a tactical and strategic commander. He made the mistake of locating his headquarters where his hindquarters should have been.


NEWS YOU CAN USE:

The WWII and terminally ill veterans have priority. Tentative dates for flights from Salt Lake City or Las Vegas are April 2-5, April 16-19, April 30-May 3, May 14-17, and May 28-31. Applications for Guardians on these flights/trips (cost of approximately \$700) are also being taken.
