During his address to the first session of the Fall NEC Meetings, National Commander Michael Helm began with a reminder that The American Legion is a "God and country" organization, and ended with a challenge to the department officials present to return home and "stoke the fires" of the Legion presence in their communities. In between, Helm used his remarks to discuss the Four Pillars that the Legion stands on, and how each of them remains highly relevant today. Three MIAs Identified

The Defense POW/MIA Accounting Agency announced the identification of remains belonging to one airman and two soldiers who had been missing and unaccounted for since World War II and Korea. Returned are:

Jay Hess

U.S. Army Air Forces 1st Lt. James F. Gatlin, 25, of Jacksonville, Fla. On Dec. 23, 1944, Gatlin was copiloting a B-26C Marauder that was shot down while on a bombing mission near Ahrweiler, Germany. Gatlin and four other crew members were reported killed in action. He was assigned to the 575th Bombardment Squadron, 391st Bombardment Group, 9th Air Force, and was buried with full military

honors Jan. 30 in Bushnell, Fla.

Army Sgt. Gilberto L. Sanchez, 19, of New Braunfels, Texas. Sanchez was assigned to Medical Company, 32nd Infantry Regiment, 31st Regimental Combat Team. His unit was deployed east of the Chosin Reservoir in North Korea when it was attacked by overwhelming numbers of Chinese forces. On Dec. 1, 1950, remnants of the 31st RCT, known historically as

Task Force Faith, began a fighting withdrawal to more defensible positions south of the reservoir. Sanchez was reported as missing in action on Dec. 2. He was buried Jan. 23 with full military honors in San Antonio.

Army Cpl. C.G. Bolden, 24, of Van Buren, Ark. Bolden was assigned to Company C, 1st Battalion, 38th Infantry Regiment, 2nd Infantry Division. He was captured by enemy forces on Jan. 5, 1951, and reportedly died in a North Korean POW Camp on April 30, 1951. He was buried Jan. 27 with full military honors in Clinton, Ark.

SEA CADET NEWS

Hello again from the Jake Garn Squadron. Our unit continues to grow. We now have 30 cadets and 16 adult leaders. During the month of February, our unit visited the 421st Fighter Squadron, Black Widows. We learned about flight equipment and even got up-close and personal with a Viper fighter aircraft. Training was conducted on flight suites, night vision goggles and ordinance that the pilot uses to operate the aircraft. It was a fascinating experience for both cadets and adults alike. Thank you 421st!

In addition to the tour, drill weekend, we were fortunate to have a VIP presentation given by Major

Triplett who outlined his amazing career flying the C-130 aircraft. Major Triplett shared personal experiences and specifications of this amazing aircraft that has been in constant production and use since 1955.

Also, this month, the cadets began learning about the history of the submarine. Instructor Leon White showed a video and gave a presentation about the restoration of the H.L. Hunley. The submarine is currently being preserved at the Warren Lasch Conservation Lab. The Hunley was the world's first successful combat submarine. Submarine training will continue during drill in May as March drill will be the unit's first inspection and April will be the unit's official commissioning. Unit commissioning is scheduled for Saturday, April 18' Hill Aerospace Museum, time TBD. We hope to see Post 27 members support the Squadron Commissioning. More information to follow. Green Beret Special

President John F. Kennedy enthusiastically championed the development of the U.S. Army's Special Forces as part of what he called the doctrine of "flexible response," an initiative to make the U.S. military more capable of fighting the guerilla or insurgent wars of the 1960s. He is widely credited with proposing the U.S. Special Forces wear a green beret to distinguish themselves. Although JFK does deserve a big share of the credit, the backstory is a bit more complicated.

The modern U.S. Army Special Forces has its origin in World War II, when the first elite Army Ranger Unit, "Darby's Rangers," was created in the summer of 1942. After forming

Kent Hansen Rangers," was created in the summer of 1942. After forming in Northern Ireland, Darby's Rangers received advanced training from British commandos at the Commando Training Depot at Achnacarry Castle, Scotland. The British encouraged the men to wear the bright green beret of the British Commando, but the U.S. Army brass banned this headgear as a violation of uniform regulations. A decade later, at the end of the Korean War, the U.S. Army's Tenth Special Forces Group (Airborne), which included a large number of World War II Darby vets, casually wore various berets, in crimson, maroon, and black before "rifle green" was officially chosen, based on a Canadian Army precedent. When the Tenth wore the new green berets during a 1955 ceremony at Fort Bragg, NC, many in attendance started asking where the "foreign delegation" had come from. A mortified Fort Bragg commandant, General Paul D. Adams, immediately banned the rifle-green beret.



When he was appointed commander of the U.S. Army Warfare Center at Fort Bragg, Brigadier General William P. Yarborough petitioned the Pentagon to reinstate the green beret for Special Forces. His request received no traction until President John F. Kennedy personally intervened, and on September 25, 1961, the Department of the Army issued

"Message 578636," designating the green beret as the "exclusive headdress" of the U.S. Army Special Forces. JFK later called it a symbol of excellence, a badge of courage, a mark of distinction in the fight for freedom."

From the Department Commander

It is that time of year again where the American Legion tries to impact legislation for our veterans and military, at state and national level. It can be mind boggling, but many good things come from all the efforts. I try to keep in mind that the GI Bill and the creation of the Veterans Administration were the brainstorms and efforts of the American Legion many years ago. Our organization is also a "watch dog". How long would the issues at today's VA gone on without the intervention by the American Legion?

One local piece of legislation, H.B. 36, Veterans Definition, is currently on the fast track to becoming state law. This would give Reserve Component (U.S. Army Reserve/Utah National Guard) members who served at least 180 days, served honorably, but were never deployed (that magic 180 days of actual Title 10 active duty) the right to call themselves "veterans". This does not mean they can get the full benefits of those who deployed or activated for 180 days, just the right to call themselves veterans.

This is huge. As I traveled throughout the state, I have been careful when talking to former members of the military services in asking if they are veterans. Many tell me no, I was just in the Reserves or National Guard and was never activated. My blood boils when members in this category don't think they are veterans, especially when they retire from the military and have the same retirement ID card as I have. We were all brothers and sisters in arms. But that is what they were told while they were serving—you cannot claim you are a "veteran". That, Comrades, is change for the better.
