#### **DID YOU KNOW?**

West Point and the Naval Academy have a football rivalry spanning more than a century. How did the tradition begin? It dates back to an 1890 bet by Naval Academy football players against their Army counterparts, according to the Philadelphia Convention & Visitors Bureau. Cadets accepted the challenge and promptly lost. The Army-Navy game quickly became an annual tradition. But it almost ended in 1893, when a fight broke out after the game between a rear admiral and brigadier general that almost ended in a duel. The war secretary and

the Navy secretary subsequently decided to ban the teams from playing each other, a ban that lasted through 1898. After the five-year interruption, Army and Navy resumed playing, with a city about halfway between the two academies - Philadelphia - serving as primary host.
